Both generate moisture vapor that must be extracted and evaporated simultaneously. A single commercial dehumidifier can handle roughly 150 to 200 pounds of water removal per day; a flooded basement may require 800 to 1,200 pounds of removal daily to avoid prolonged-exposure risk.
