Begin With a Complete Office Assessment

Organize and Reduce Office Inventory

Moving is a practical opportunity to remove items that are no longer useful. Review outdated files, broken equipment, unused furniture, duplicate supplies, and old office materials before packing begins. Items that do not need to be transported can be donated, recycled, stored, or disposed of.

Reducing unnecessary belongings can save space, labor, packing materials, and transportation time. It also allows the business to create a cleaner and more functional workplace at the new location.



Prepare an inventory of the items that will be moved. Important furniture, electronics, documents, and equipment should be identified so the business can confirm that everything arrived at the destination.

Use Professional Office Packing Services

Office packing should be completed according to the type of item being moved. Heavy books and files should be placed in strong boxes, while lighter supplies can be packed in larger containers. Fragile electronics, glass furniture, artwork, and delicate equipment require additional protection.
