

A truck wreck is not a car wreck. A loaded tractor trailer can weigh many times what your car weighs, and the injuries are usually far worse.

The difference starts in the first hours. The trucking company often sends its own people to the scene the same day, while you are still in the emergency room. They begin building the company's side of the case right away.

More than one company can be responsible. The carrier, a maintenance provider, a broker, or the company that loaded the cargo may each share responsibility. Each of those is its own question **Atlanta workplace injury lawyer** with its own evidence.

Commercial trucks also create records an ordinary car never does: hours of service logs, engine and braking data, maintenance and inspection files, and the driver qualification file. A lot of it can be purged in the ordinary course of business, which is why a preservation demand usually goes out early.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
