Also called a property settlement agreement or marital settlement agreement, this written contract addresses the division of the marital estate, any spousal support obligations, and when children are involved, the custody, visitation, and support arrangements that will govern the family's new structure. The timing of a separation agreement relative to the divorce filing has significant practical implications. When the divorcing spouses have no minor children and execute a comprehensive separation agreement, the required separation period for a no-fault divorce is reduced from one year to six months. This incentive makes a well-drafted separation agreement worth pursuing early in the separation period for eligible couples. When children are involved, the separation period remains one year, but a separation agreement that addresses custody and support still provides the parties with finalized arrangements and can be incorporated into the final divorce decree. A separation agreement is only as protective as its drafting. Ambiguous terms, incomplete coverage of assets or debts, and provisions that do not survive later scrutiny under Virginia law can create future disputes that are more difficult and expensive to resolve than the original negotiation would have been.
