

If you were riding and a driver did not see you in Georgia, there is a prior you have to overcome.

There is a built in bias in motorcycle claims: that the rider was going too fast, was weaving through traffic, or accepted a risk nobody else would.

Occasionally that is true. More often a driver looked and did not register a single headlight.
