

How the Anion Gap Indicates

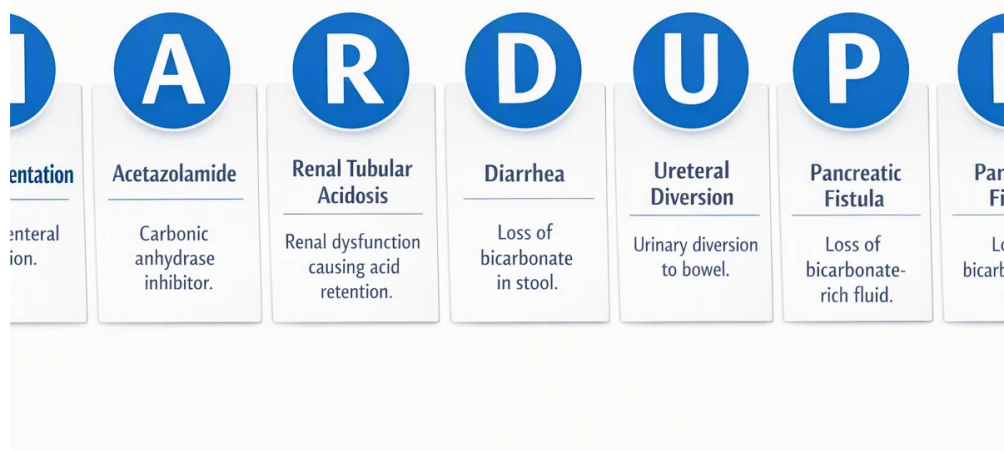
Standard vs Elevated Anion Gap
