

If you were riding and someone turned across your path around Atlanta, there is a prior you have to overcome.

Adjusters and jurors bring **local car wreck lawyer** an assumption to these cases: that the rider was going too fast, was weaving through traffic, or accepted a risk nobody else would.

Occasionally that is true. More often a driver looked and did not register a single headlight.
