

If you or your child were bitten in Atlanta, the rules may not be what you assume.

Certain states impose liability regardless of the animal's history. That is not the Georgia rule. The question is normally whether the owner knew the animal was dangerous, or whether the dog was loose in violation of a local leash ordinance.

The knowledge route is hard to prove. People do not readily admit their dog has a history, and neighbors are often reluctant to get involved.

The ordinance route is frequently more provable, which is why the first questions are about where the dog was and whether a complaint was ever filed.

This evidence does not last. County records and recollections both fade, [experienced personal injury lawyer](#) and the dog itself may be gone before anyone captures what it had done before.

#### **How much does a personal injury lawyer cost in Atlanta?**

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery. ## **How long do I have to file an injury claim in Georgia?**

Georgia generally gives an injured person two years from the date of the injury to file a personal injury lawsuit, and a claim against a city, county or state agency can require written notice far sooner than that. Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
