

If you were riding and a [car wreck injury lawyer](#) driver did not see you in Atlanta, there is a prior you have to overcome.

Adjusters and jurors bring an assumption to these cases: that the rider was speeding, was lane splitting or weaving, or took a risk a car driver would not.

Sometimes that is accurate. Usually the car turned left across a rider who had the right of way.

These cases get built on physical evidence rather than narrative, because narrative starts at a disadvantage. Damage patterns carry more weight than either version of events.

Injury severity cuts both ways. A rider has no structure around them, so the same impact produces far worse injuries. The defense response is often to argue the rider accepted that risk by riding at all.
