

A rideshare wreck raises a question <https://felixhciv464.inkharbory.com/posts/personal-injury-lawyer-in-atlanta> a normal car crash does not: which insurance policy actually applies. The answer depends on what the driver was doing at that exact moment.

If the app is off, it is an ordinary car wreck, and their personal policy applies. When the app is on and they are waiting for a ride request, a smaller layer of coverage generally applies. Once they have accepted a ride or have a passenger in the car, a much larger commercial policy typically comes into play.

Whether you were riding, driving another car, walking or on a bike changes the analysis too. Each position can reach a different layer of coverage.
