Is It Normal to Have a Headache After a Car Accident?

Headaches can occur after motor vehicle collisions, particularly when the head, neck, or upper body experiences sudden movement.

Possible contributors may include neck strain, muscle tension, changes in cervical movement, or other musculoskeletal factors. However, a headache following an accident should not automatically be assumed to originate from the neck.

Head trauma and concussion can also cause headaches, which is why the patient's other symptoms and the circumstances of the collision matter.

How Neck Injuries Can Be Associated With Headaches

The neck contains joints, muscles, ligaments, and other structures that can become irritated following sudden movement or injury.

Some people who develop headaches after an accident also notice:

- Neck stiffness
- Pain near the base of the skull
- Reduced ability to turn the head
- Upper-back or shoulder tension
- Pain influenced by neck position or movement

Whiplash and Post-Accident Headaches

Whiplash commonly involves sudden movement of the neck during an automobile collision. Headaches can occur along with other whiplash-related complaints such as stiffness, neck discomfort, and reduced range of motion.

Not every post-accident headache is caused by whiplash, however. An appropriate examination is important before determining the likely source of symptoms.

Headache or Concussion? Why the Difference Matters

A concussion is a type of traumatic brain injury and requires appropriate medical assessment. Chiropractic care should not be used as a substitute for evaluation of a suspected brain injury.

Following a crash, seek prompt medical attention when a headache is accompanied by symptoms such as:

- Loss of consciousness
- Repeated vomiting
- Increasing confusion
- Unusual drowsiness
- Difficulty speaking
- Problems with balance or walking
- New weakness or numbness
- Seizure
- A severe or rapidly worsening headache

Anyone concerned about a possible concussion should seek appropriate medical care.

Why Headaches May Develop Later

Some people do not recognize neck stiffness or headache symptoms immediately after a collision. Once the initial stress of the event passes and normal activities resume, symptoms may become more noticeable.

This is one reason it can be useful to pay attention to changes in comfort and mobility during the days following an accident rather than relying exclusively on how you felt at the scene.

What a Chiropractor Checks When Headaches Follow an Accident

If serious head injury has been ruled out and musculoskeletal symptoms remain, a chiropractic examination may evaluate:

- Neck range of motion
- Joint movement
- Muscle tension and tenderness
- Upper-back and shoulder mobility
- Posture and movement patterns
- Movements or positions that reproduce symptoms
- Previous headache or neck-pain history

This information can help determine whether the patient's neck or surrounding musculoskeletal structures may be contributing to their symptoms.

What Should You Track After the Accident?

Keeping simple notes about symptoms can make it easier to explain what has changed since the collision.

Helpful information may include:

- When the headache began
- Where the pain is located
- How long it lasts
- Whether neck movement changes the headache
- Whether dizziness, nausea, or vision changes occur
- Whether symptoms are improving, stable, or worsening

This information does not replace an examination, but it can help healthcare providers understand the pattern of symptoms.
