

Losing someone in a preventable crash is not a legal problem first. It becomes one eventually, usually when the bills arrive or an insurer calls.

Georgia treats a death case differently than people tend to assume. There are generally two separate claims. One belongs to the surviving family for what Georgia calls the full value of the life of the person who died. The other belongs to the estate and covers things like the final medical bills, the funeral, and any conscious suffering before death.

Georgia law sets an order for who may bring that first claim. A surviving spouse generally comes first, then children, then parents, and then the estate. Where there is a spouse and children, Georgia also sets a minimum share for the spouse.

Deadlines apply, and some are shorter than people expect. A claim against a government entity can require written notice far sooner than the filing deadline. Evidence also disappears, particularly where a commercial vehicle or a business is involved.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
