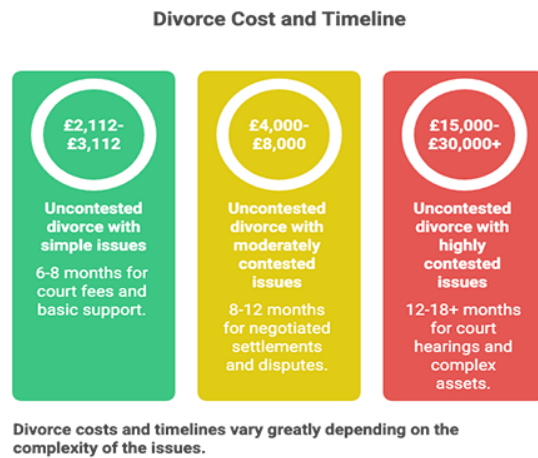
Zoom Suggestions And Troubleshooting
