

If you were hurt on a bus around Atlanta, the timeline is not the usual one.

The general Georgia deadline for injury suits is two years. Where a government entity owns the bus, written notice may be due in months rather than years, and it has to be in the right form and go to the right place.

A late notice can close a good claim before anyone looks at the merits.

Who owns the bus drives the analysis. Injuries on a public transit bus, a school bus, [car wreck settlement lawyer](#) a private charter and a hotel shuttle each run on different rules. It sets the deadline, the immunity questions and the coverage available.

Video is the other clock. Buses are heavily camerad, inside and out, and retention is often measured in days or weeks. Ask too late and there is nothing left to preserve.
