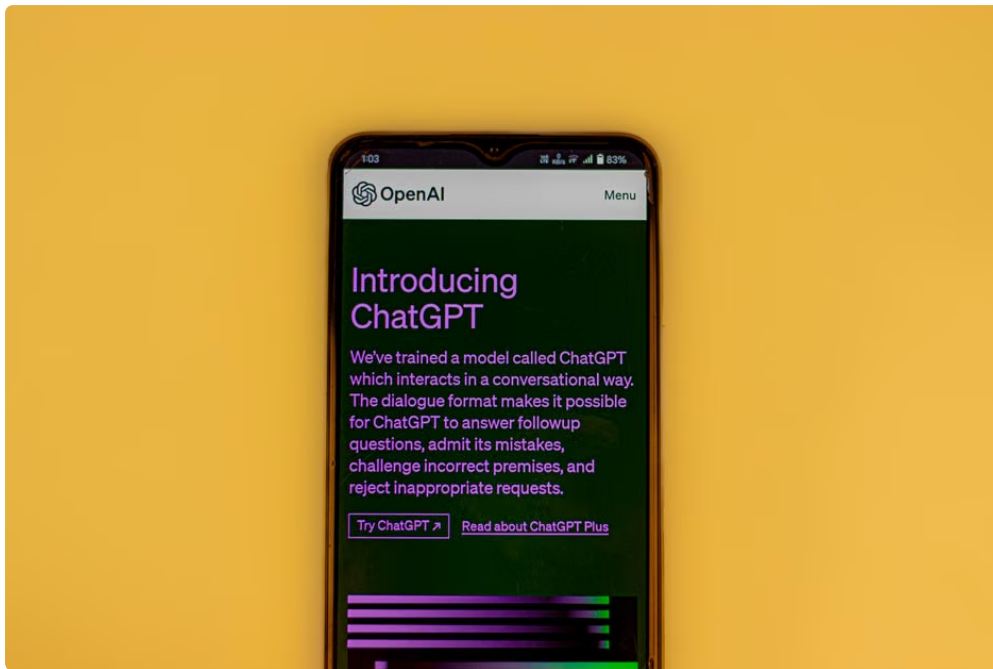

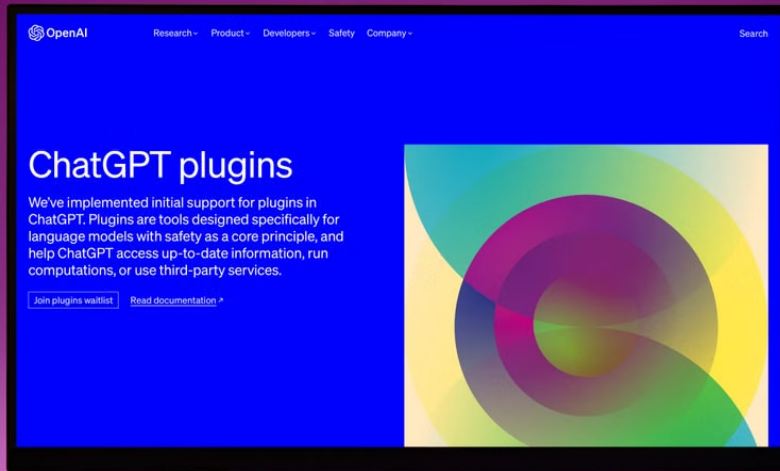

## ChatGPT is an OpenAI Product, Not a Separate Company

## Key OpenAI Entities: OpenAI Group PBC, OpenAI Foundation, and Others

The OpenAI ecosystem encompasses several entities, each serving a different role. The following are the most relevant when understanding contractual relationships:

- **OpenAI Group PBC:** A Public Benefit Corporation (PBC) that acts as the top-level holding and governance entity. It oversees the broader group and weighs public benefits alongside profit considerations.
- **OpenAI Foundation:** A non-profit entity created to ensure the mission continuity and governance control of OpenAI Group PBC. It holds special rights in governance structures, including board control.

- **OpenAI Foundation:** Holds special governance rights and ensures mission adherence. It controls board composition through these rights, enabling strong influence on the group's direction.
- **OpenAI Opco LLC:** The operational, commercial entity that delivers ChatGPT and other products and signs contracts with customers worldwide.

This design allows OpenAI to pursue ambitious AI goals while providing commercial services.

## Economic Stake: Volatile and Often Misreported

The economic ownership of OpenAI is complex and frequently misrepresented.

OpenAI's investor and stakeholder landscape undergoes frequent changes as new financing rounds, investments, and stock allocations occur. Notably:

- Major technology companies and investors hold equity stakes in OpenAI Opco LLC and its parent group.
- The **OpenAI Foundation** generally does not have an economic stake but wields special governance rights to guarantee mission alignment.
- Economic interests fluctuating over time mean ownership shares and valuations can shift rapidly.

If you are in the UK and use ChatGPT, you agree to terms of use published by OpenAI. The current terms frameworks relevant are:

- OpenAI Terms of Use (European Terms): Applicable to users in the European Economic Area and the UK, compliant with regional legal and data protection standards.
- OpenAI rest-of-world Terms of Use: Applicable globally outside the European regions.

Though the UK has left the EU, OpenAI currently treats UK users similarly to EU users, making the European terms most relevant for **uk user contract** considerations.
