

If you were riding and someone turned across your path in Georgia, the assumption is already working against you.

People arrive with a view already formed: that the rider was speeding, was lane splitting or weaving, or took a risk a car driver would not.

Occasionally that is true. Usually the car turned left across a rider who had the right of way.

The work is physical evidence, not story, because narrative starts at a disadvantage. The geometry of the turn do the arguing.

Severity helps and hurts. There is nothing around a rider, so the same impact produces far worse injuries. The defense response is often to argue the rider accepted that risk by riding at all.
