

A truck crash is not the same as a car crash. A loaded tractor trailer can weigh many times what your car weighs, and the injuries are usually far worse.

The difference starts in the first hours. Trucking companies frequently send an investigator to the scene before the road is even clear, before you are out of the hospital. They start protecting the company immediately.

Responsibility can reach past the driver. The carrier, a maintenance provider, a broker, or the company that loaded the cargo may each share responsibility. Each of those is its own question with its own evidence.

A commercial truck generates paperwork a passenger car never will: electronic logging records, engine data, maintenance history, and the file the carrier keeps on the driver. Much of it can be overwritten or discarded on a normal schedule, so a preservation demand is typically sent right away.

## **How much does a personal injury lawyer cost in Atlanta?**

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery. ## **What should I do after a truck accident in Atlanta?**

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
