

What Is the Anion Gap?

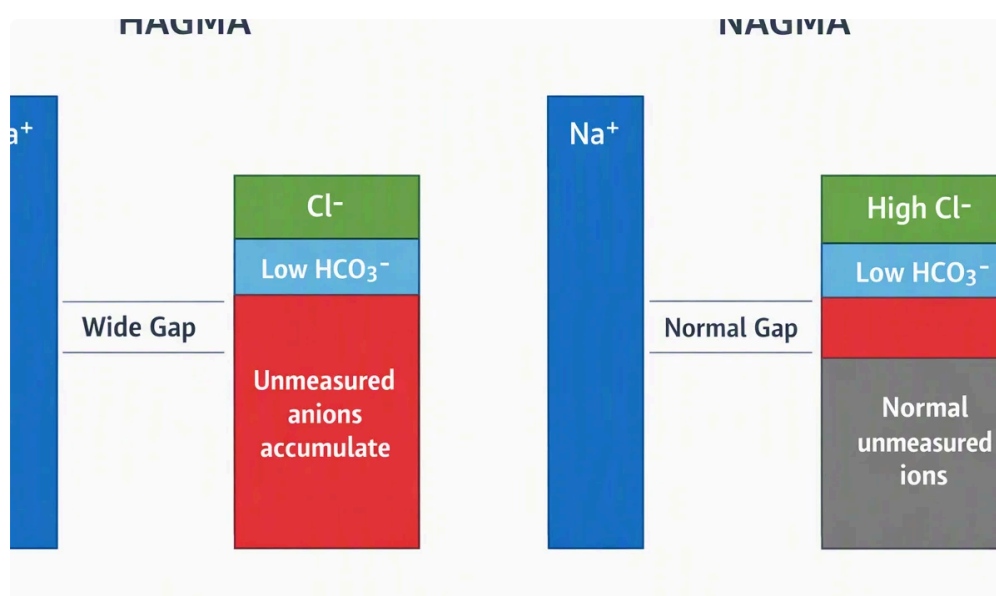
The **anion gap** is a calculated value used to help assess **acid-base balance** and detect certain types of **electrolyte imbalance**. It compares the main **measured cations** and **measured anions** in blood chemistry, especially **sodium** and **chloride**, along with bicarbonate-related values. Clinicians use it as part of a broader look at **serum chemistry** and overall **clinical interpretation**.
