Develop an Office Inventory

An accurate inventory helps both the business and moving company understand the size and complexity of the relocation. Walk through the entire office and document furniture, equipment, boxes, appliances, supplies, and other property that will be moved.

Divide the inventory by department or area when practical. For example, you might create separate sections for reception, accounting, conference rooms, employee workstations, storage rooms, kitchens, and management offices.

An inventory can also help identify items that should not be moved. Old furniture, outdated equipment, unused supplies, and duplicate materials can often be donated, recycled, sold, or discarded before the relocation.

Consider Furniture Disassembly and Reassembly

The best approach depends on your business structure, staffing, equipment, and schedule.

Ask About Short-Term or Long-Term Storage

Storage can be valuable when there is a gap between office locations or when the new workspace is smaller than the previous one. Some companies also need temporary storage during renovations or office redesigns.

For example, labels could indicate a department name, room number, workstation number, or specific destination. Color-coded or numbered systems can also be useful if they are easy for employees and movers to understand.

Consider creating a master floor plan showing where each department, workstation, and major piece of furniture belongs. Give a copy to the moving crew so items can be placed correctly as they are unloaded.
