

Anion Gap Basics

The **anion gap** is a derived value used to measure **acid-base balance** and uncover hidden changes in **serum electrolytes**. It is derived from standard blood chemistry values and helps clinicians spot an **electrolyte imbalance** that may not be obvious from a simple review of the **electrolytes** alone. In practice, the anion gap is often used as a **diagnostic tool** in the assessment of **metabolic acidosis** and other **metabolic disturbance** patterns.

The calculation primarily uses **serum sodium**, **serum chloride**, and **serum bicarbonate**, with **potassium** sometimes included depending on the method or **laboratory reference range** used. Next, compare the fall in bicarbonate from a normal normal value of 24 mEq/L:

$$\text{Delta bicarbonate} = 24 - 16 = 8$$

Now determine the **delta ratio**:

$$\text{Delta ratio} = 14 / 8 = 1.75$$

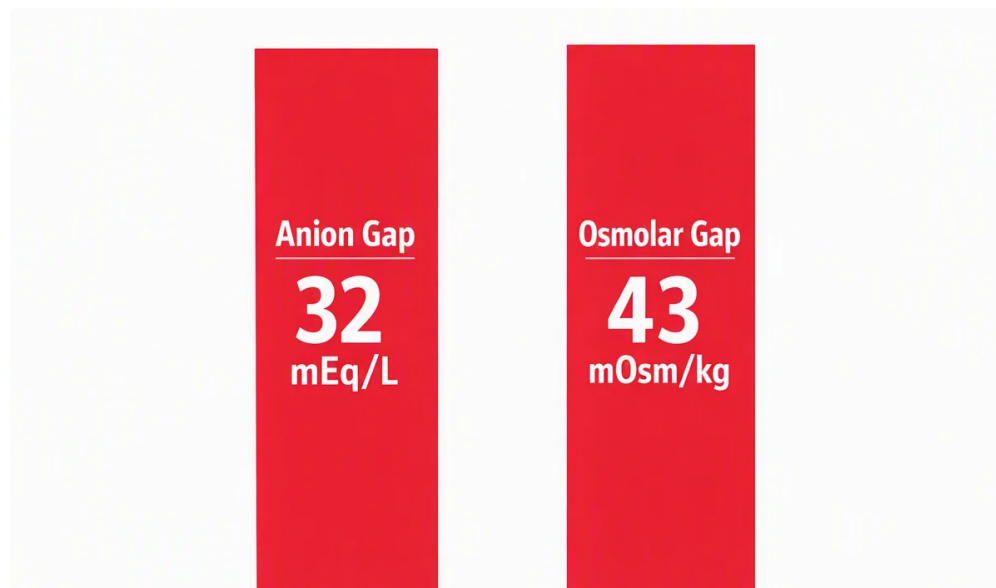

- **Lactic acidosis**
- **Ketoacidosis**
- **Renal failure**
- **Toxic alcohols**

Lactic acidosis happens when lactate builds up due to hypoperfusion, sepsis, shock, seizures, or other causes of tissue oxygen imbalance. It is a significant cause of **anion excess** and can lead to marked metabolic derangement.
