

If you were hurt by electrical contact in Georgia, several companies may share responsibility.

A site has an owner, a general contractor, the electrical sub, sometimes [truck accident lawyer](#) the utility, occasionally an equipment maker, and sometimes a staffing agency. Each has different insurance and different incentives to point at the others.

If the injury happened at work, workers compensation covers medical treatment and part of your lost wages, and it prevents you from suing the employer directly. It does not bar a claim against a third party whose conduct created the hazard.

The claim against the other company is normally where the meaningful money is, because comp does not pay for pain, disfigurement, or the full economic loss of a career that ended early.

Working out who [18-wheeler truck accident lawyer](#) was responsible means getting the contracts, the safety plan and the daily logs, and none of that is available just for the asking.
