

If you or your child were bitten in the Atlanta area, the rules may not be what you assume.

Some states hold the owner responsible no matter what. Georgia is not one of them. The question is normally whether the owner knew the animal was dangerous, or whether the dog was loose in violation of a local leash ordinance.

The knowledge route is hard to prove. People do not readily admit their dog has a history, and neighbors are often reluctant to get involved.

A leash law violation is often the clearer path, so the early questions focus on whether the animal was restrained and whether a complaint was ever filed.

This evidence does not last. Animal control files and witness memory both degrade, and the animal may be rehomed or euthanized before its [truck accident lawyer](#) history is ever documented.
