

The first time I saw people argue about the **tropicana cherry strain price**, it wasn't really about the number. It was about what that number was supposed to mean. If you do those checks and the product still costs more, you're not necessarily being overcharged. You might simply be buying the better batch.

But if the signals are mediocre and the price is high, that's a pass. There will be another drop.

This is the part that deserves honesty. Even when a strain is real and well-known, premium labels don't guarantee your personal preferences will line up with that batch.
