

When a family loses someone in a preventable wreck, the legal question is not the first thing on anyone's mind. It becomes one later, often when the bills arrive or an adjuster calls.

Georgia treats a death case differently than people tend to assume. Two separate claims generally exist. One belongs to the surviving family and covers what the law calls the full value of the life that was lost. The other belongs to the estate and covers things like the final medical bills, the funeral, and any conscious suffering before death.

Georgia law sets an order for who may bring that first claim. It generally begins with a surviving spouse, then children, then parents, and then the estate. When there is a surviving spouse and children, the law also sets a floor [atlanta personal injury attorney](#) on the spouse's share.

Deadlines apply, and some are shorter than people expect. A claim against a government entity can require written notice far sooner than the filing deadline. Evidence also thins out, especially when a company vehicle or a business is involved.
