

When a dog attack leaves someone hurt around Atlanta, the rules may not be what you assume.

Some states hold the owner responsible no matter what. Georgia does not work that way. The claim generally turns on whether the owner had reason to know the dog was vicious, or whether a leash law was being broken at the time.

Establishing what the owner knew is not easy. People do not readily admit their dog has a history, and witnesses on the same street tend to stay quiet.

Local ordinance violations are usually easier to establish, which is why the first questions are about where the dog was and whether anyone contacted animal control.

Records disappear quickly here. Animal control files and witness memory both degrade, and the [local personal injury lawyer in Atlanta](#) animal may be rehomed or euthanized before its history is ever documented.
