

If you were riding and were hit in Georgia, you are starting from behind.

Adjusters and jurors bring an assumption to these cases: that the rider was going too fast, was lane splitting or weaving, or took a risk a car driver would not.

Sometimes it fits. Usually the car turned left across a rider who had the right of way.

Reconstruction matters more here than testimony, because narrative starts at a disadvantage. Sight line analysis carry more weight than either version of events.

Severity helps and hurts. **local car accident lawyer** A rider has no structure around them, so the same impact produces far worse injuries. The defense response is often to argue the rider accepted that risk by riding at all.
